Judging Criteria

Overall judging criteria will include design, workmanship, creativity, functionality, technical innovation, economy and problem solving. The _____ Chapter – ACI recognizes the professionalism and expertise of the individual jurors. _____ Chapter – ACI encourages and supports the jury's discretion in its choice of projects. Decision of the jury will determine the awards for each category, which could award more than one or no award in categories if decided.

Awards will be given to the **architect of record, engineer of record, general contractor, major concrete supplier and the concrete contractor**. Please make sure to list all companies that apply on submittal.

NEW THIS YEAR: The jury will be asked to choose an **‘Overall Top Project’**. This project will be entered into the ACI National Awards competition, the inaugural program will take place at the Fall 2015 ACI Convention in Denver, CO.

Presentation of awards will take place at the _____ Chapter – American Concrete Institute's Concrete Awards Banquet, **April 11, 2014** at _____ Hotel and Casino.

Eligibility:

1. Concrete or concrete products must be the predominant component highlighted.
 2. Projects must be completed between January 1, 2009 and January 1, 2014. (Concrete part must be complete and the project itself should be substantionally completed by this date)
 3. Projects must be located within the state of _____.
 4. Project must be new construction, re-construction, restoration or repair.
- There is no limit to the number of projects entered per company or per category.

“Exposing the Best in Concrete Awards Program” **Entry Instructions**

Important Notes:

- All entry pages (originals and 6 copies) are to be *3-hole punched*
- Enclosed sheets may be used as submittal pages. Entries may be submitted on non-provided pages, however, all submittals must be *8 1/2” x 11”*, *3– hole punched* and include *entry number in the upper right-hand corner* of the page.
- No submittal package shall contain the name of any project participants or the name of the submitter. Only the Project Information Form & Release Form should have project participants, submitter, owner, & photographer names listed; provide as indicated on each form.
- All originals are to be placed in the folder provided *in the order specified below*.
- Additional required copies (see Items 3 - 9) are to be *collated in the order specified below and placed into the front (left) pocket* of the entry folder.
- The photo flashdrive is to be placed in the *back* pocket of the entry folder.

Entry Format:

All *originals* of entry materials must be contained in the enclosed folder in the following order (*all copies are to be collated in the following order and included separately*):

1. Project Information Form (*1 copy*). This form will remain at the ACI office until after jury selections.
2. Release form (*1 copy*) applicable signatures needed. This form is to be submitted with Project information form.
3. Project identification form for submittal (*1 original, 6 copies*) This will be page 1 of the jury submittal package.
4. Project Description – Use of concrete in design (*1 original, 6 Copies*). A thorough description of the project, emphasizing the attributes of concrete.
5. Site Plan – (*1 original, 6 Copies*) Site plan showing location of building on property, key features, etc.
6. Floor Plan – (*1 original, 6 Copies*) showing complete layout of building.
7. Concrete Details -- (*1 original, 6 Copies*) (optional page) Workmanship is part of the judging criteria. Unusual detail drawings are of interest to the jury. *Please insert blank page if not submitting drawings.*
8. Photo Image Identification Form -- (*1 original, 6 Copies*) Identify photos and give brief description for jury’s reference.
9. Photo Images– (*1 copy*) **Minimum 6 images, maximum 10**. Include elevations, special concrete details, and overall view of project. **DIGITAL IMAGES REQUIRED: 1200 x 1500 pixels (8 x 10 at 150 resolution)**. The digital images should be submitted on a flashdrive, labeled with the entry number. The digital images on the drive should be numbered and appear in the order that the images are to appear during judging.
10. 8X10 Picture – copy will be submitted to the jury.
