2.0 Approval of the Minutes from the Meeting in Washington DC, March 17, 2004

3.0 New Members

Kelly Page and Fred Goodwin were recently appointed as members of TRRC. Recommendations for new members will be discussed.

4.0 Repair Issues in 318 – White paper on economic impact of current practice (Paul, Emmons)

At the Fall 2003 meeting in Boston, Chair McDonald appointed a Task Group (chaired by Paul with members Emmons, Kahn, and Poston) to develop a list of questions for use in developing a proposal to TAC.

In Washington DC, Paul reported on the draft document entitled, “Review of ACI 318-02 for Repair Applications,” that was distributed to members of ACI Committees 364 and 546 for comment. Although he received little feedback, it showed that the scope of the issue is a lot greater than originally anticipated.

A discussion resulted in an agreement that a white paper on economic impact of current practice should be developed.

Paul is to report on the Task Group activities since the Washington DC meeting. Emmons will discuss how the white paper relates to Vision 2020.

5.0 Vision 2020 (Emmons)

Emmons will report on the March 2004 workshop in Chicago to identify goals, objectives, and roadmaps for the concrete repair and protection industry. He will also provide a status report on the Vision 2020 report and discuss the Fifth International Workshop, “Roadmapping Improvements in the Concrete Repair Industry,” scheduled for May 2005, Sedona, AZ.

6.0 Update on the Concrete Repair Manual (Emmons)

A schedule for development of the next edition will be discussed.

7.0 Website Fixconcrete.org (Emmons)

A link to the Fixconcrete.org website has been provided on the ACI website homepage. Several sessions from the Spring Convention were to be taped and posted to the website in accordance with the procedures mentioned in the January 17, 2003 TRRC Baltimore Meeting Minutes. TRRC members should review and have 30 days to object to material posted to the site.

Emmons reported in Washington DC about problems with UMR, and the plan to terminate the relationship and move the website hosting service to a private company (Interland). An option was being considered in having the site be sponsor-driven.

Emmons is to report on further progress.

8.0 Repair Material Datasheet Protocol (Goodwin)

Kelly Page (ICRI) reported in Washington DC that the Repair Material Data Sheet Protocol (RMDSP) was in its final review within ICRI. ACI Committee 364 was in the

process of reviewing the draft document and developing a commentary. TRRC recommended that the second version of the document to be a joint ACI/ICRI document.

Goodwin is to report on the status of RMDSP.

9.0 FAQ # 4 (McDonald)

At the Boston meeting, TRRC developed language on formal procedures for reviewing and publishing FAQs for inclusion in the TCM, and the draft was forwarded to the TAC TCM Task Group.

At the Washington DC meeting, Sneed distributed the report on the status of the existing FAQs. Chair McDonald suggested that ACI Committee 546 start generating repair-related FAQs.

Chair McDonald is to report on FAQ # 4.

10.0 Implementation of the TRRC Action Plan (McDonald)

Chair McDonald informed members in an e-mail dated August 26, 2004 that the action plan has finally been approved by TAC. A copy of the approved version was attached.

Implementation of the plan will be a major part of our discussions at the San Francisco meeting, so all members were encouraged to bring their ideas.
