In October 2016, the Standards Board granted approval to release the draft standard for public discussion and to process it as an ACI standard. Public discussion was announced on October 26, 2016, and closed on December 10, 2016. The committee responded to the public discussion. TAC reviewed the closure and approved it in May 2018. The Standards Board approved publication of the ACI standard in June 2018.

Specification for Inspection of Concrete Construction (ACI 311.7)
